His face is white, his eyes are cloudy, his hearing diminished and he can no longer get in and out of the car unassisted. But his heart is still a bright shiny gold and he starts each day with his tail wagging and the attitude of a 2 year old asking "what will we do today?" Finn is now 14`1/2 years and has always enjoyed whatever the day had in store.

It is said that the Golden Retriever is a very versatile, cheerful dog that enjoys participating in many activities and events. Finn is a perfect example of that. He has earned 26 titles in obedience, agility, field and tracking. And he has done it with great style, a true joy to watch. The bond between Kathy and Finn is very apparent whatever the venue of the day. I know that watching Finn inspired many of us to be better trainers and spend more time doing things with our dogs for he made it look so much fun! He was certainly a great performance dog.

But the Finn I know is more than that. His sweet way of standing by the side of the bed, while Kathy crawls in, and waits for her to invite him up – his searching my car for ducks wherever it is parked – his patience with Peep who has to kiss him whenever she sees him (even though she is annoying!) – his willingness to share his home when the next pup arrives and his great love of life. He has made us all laugh at field training days. For 3 years I have thrown him birds and sent him to retrieve to have him bring the duck back and search for Kathy to deliver it to her. Finally this year he gave me the honor of bringing me the duck – but only once or twice.

For years Finn visited an assisted care facility with his pet sitter. Loving people and making friends wherever he goes and he was a great hit with the residents there. He has also entertained many kids by dressing up on Halloween to give out candy. And this gentle dog is the dog of choice to greet Kathy's small nieces and nephews who are not that brave around the dogs. He sits quietly showing them they have nothing to fear and of course he is rewarded with a treat or light touch. In his 14 ½ years, his contribution to his family, his community and all his training groups, both human and canine, have certainly been Golden. He's made us laugh, he's made us want to be better trainers and has showed us what a Golden could and should be. Finn has touched many hearts including mine. So although he is not my dog, he is my buddy and my choice for the Heart of Gold Award because he truly has a heart of gold.

GRCCNY TO OFFER CCA (CERTIFICATE OF CONFORMATION ASSESSMENT) ON APRIL 4

Our club will offer GRCA's Noncompetitive Conformation Assessment on April 4 at the SOTC Building, Deere Road, Syracuse. But not all of our members know what it is.

The purpose of the CCA program is to provide, in a noncompetitive event, a means of evaluating and scoring the conformation qualities of a Golden Retriever, using the breed standard as opposed to the "dog-to-dog" comparison as in a dog show competition. It provides an informative assessment by knowledgeable evaluators and a written record of that evaluation. Any Golden over the age of 18 months that is registered with the AKC or CKC or has the AKC PAL number may participate. Owners need not be a member of this club or GRCA and are encouraged to present their own dogs as this program is intended for educational purposes. Females in season must be presented only after all male dogs entered in the event have been presented. When the flyer becomes available it will be sent to our Club's membership electronically.

GRC-CNY Members Attend Golden Retriever Club of America National Specialty

This Specialty was an event of superlatives...the largest national breed club, largest national specialty, largest obedience trial in AKC history in one of the most beautiful and hospitable regions of this country and with and for the very best of breeds!!!! Club members Carol Allen, Bruce and Audrey Coleman, Connie Craig, Pam Fuller, Beth Greenfield, Sallie Lennox, Beth and Lee Painting traveled to Asheville, North Carolina in late October – think amazing fall colors in the Great Smokey Mountains. “Breathtakingly beautiful” is how several of our members described it.

The Specialty was actually a 3-state event. Conformation, obedience, rally, agility, CCA, meetings, parades, dinners, gala, vendors were at the Western North Carolina Agricultural Center in Fletcher, NC (10 miles for Asheville); The Hunt test was in Bristol, Tennessee; the Field Trial was in Cheraw, South Carolina, and Tracking was held in the Asheville area. This gave even more opportunity for travel in this amazing area.

Best of Breed, to the great delight of so many of us who favor the seniors, was CH Goodtime’s Johnny Bee Good, owned and handled by Courtney Corral. “Johnny”, age 9, came out of the Veteran Class. What a marvelous dog!! Another surprise, only because of its rarity, was Best of Winners – Ventess Sophia of Goldensglen, a European-style Golden. And we cheered on “Robin”, CH Nitro’s Boy Wonder and Mary McQueen in Veterans 12+, only to be saddened within a couple of weeks by news of the passing of Robin. Our condolences to Mary who is known to many of our members and is a member of our neighbor club, GRC-Western NY.

From Bruce and Audrey Coleman: It was a 9-day trip with 6 straight days of events. Saturday and Sunday found us at the field events in Bristol, Tennessee, where Fanny passed the Senior Hunter Test and then Fanny, Kate and Rocket (at age 13) passed the WC test. Monday found us in Fletcher and we applauded James, a son of our Ditto, as he earned his CCA. Tuesday and Wednesday was the largest Obedience Trial in AKC history. There were 321 dogs entered in Obedience with a total of 520 entries and 204 dogs entered in Rally with a total of 248 entries. It took 2 days to complete one trial. Tuesday was primarily for the non-regular classes. Our Vinny qualified in Veteran’s Novice Obedience and we fielded a team for the team competition with 11 teams entered in matching clothing/costumes and each team having 4 dogs and their handlers. We were the “Damn Yankees”: Bruce with Vinny, Audrey with Fanny and Kathy Wager and Diane Blackman with their Golden. When the judge asked if we were ready, we responded in unison “Batter Up”. Audrey says she enjoyed the Team Obedience the most for its “roll on the floor” fun and it is non-stressful for the participants. Also, the judges in the field events went out of their way to make people feel comfortable with the tests and they stressed the “fun” aspects of working with our dogs. Something we noticed: how few vendors there were.

Then on to Conformation. Bruce and Audrey’s Vinny, handled by friend Beth Durand, took a first in the Sweepstakes Gun Dog ***Field Class

- “BEST MEMORY EVER AND THRILL OF A LIFETIME”.....”I entered my McIntyre (CH Gingerrun Saquish Golden Pine Mac TDX) in Veteran 8-10, both Sweeps and regular Classes. Although he has been retired from Conformation since the age of 2, we were there anyway, so why not? Mac placed 4th in the regular class, Veterans 8-10, and made the cut in Veteran Sweeps, handled by “Aunt” Nancy Kelly. And his buddy, Johnny, went on to win the Regular Veteran 8-10 class, move up to Best of Breed and WIN Best of Breed, becoming only the 4th Veteran ever to go Best of Breed!!!) What an awesome week!”

From Beth Greenfield: “This monumental show includes all that Golden Retrievers do. My first event was as an Evaluator at the CCA. The entries were 140 dogs with only 2 flights of 21 dogs each. I evaluated with Marcia Schlehr and Laurie Doumaux (both very well known in the Golden “world”) and I felt like I was taking a master class with them. I was trying to make sure I was using the correct canine terminology on my score sheets and, at the same time, teaching the elements but, at the end my scores were right in line with theirs. Whew! We had a wonderful mix of dogs from those entered in conformation, field, obedience, and rally all week. I also evaluated a nice male that was in training as a service dog for a young teen. On Tuesday and Wednesday I entered my three Golden Retrievers in Obedience and Rally. The building held 5 rings including the largest Rally ring I have ever worked in. The Chairperson for this (Susan Young) was superb. Everything ran so smoothly. There was plenty of room for crates and the local dog training club provided ring stewards. Every possible accommodation was made for conflicts and all exhibitors were very supportive of each other. Then off to the Judges’ Education Seminar where I was one of a group of 5 judges mentoring judging applicants. Thursday I mentored ringside in the Judges’ education area. Later “Brees” and I did a quick stint in Senior handling showing off some of her rally moves. Then off to the formal Golden Retriever Foundation Gala with the customary Top Twenty Parade, noting that some of the dogs shown were past winners of the GRCCNY Specialty. But, all said, the best part of the trip was the drive through some spectacular mountains and meeting people I don’t see often, and some on my Facebook page.”

Carol Allen thought, as did so many others, “that the area itself was a highlight of the week. And the hospitality shown by Sandlapper GR Club and the Specialty Co-chairs, Barbara Pepper and Collette Jaynes. We took no dogs, leaving us time (and energy) to volunteer and socialize. Sallie and I volunteered by covering the Welcome Table for about a day and a half and this is an ideal place to meet people as this is where catalogs are picked up – you see just about everyone sooner or later. Sallie also volunteered in the VIP area ringside. I had a very productive meeting with the GRCA President who has chosen to be the Board liaison to Rescue, and then assisted at the Rescue Parade, and conducted the Annual Rescue Meeting. I attended the GRF Gala/Top Twenty and was happy to see there Beth, Greenfield, Connie Craig and Beth and Lee Painting. Everyone looked like a million dollars in their more formal wear. At the Annual GRCA Meeting I presented the Starfish Award and later at the GRCA Board Meeting I was reappointed for the 13th year as National Rescue Chair. The Halloween Party will always stand out as much fun - so many (dogs and people) in costumes and so many GR Clubs having tables with free-flowing drinks and food. One of the best was that of our neighbor, Autumn Valley GR Club and Connie Craig was a delightful server.”

And now on to Wilmington, Ohio for the 2015 National Specialty, September 25 to October 5, 2015, hosted by the Greater Cincinnati Golden Retriever Club.



WC/WCX, and a little history (by Maxine Clark)

We all know that the Golden Retriever originated in Scotland in the late 1800’s and started appearing in the United States some years before their official recognition by the AKC in 1932. In 1938 The Golden Retriever Club of America was incorporated stating the object of the club being that the Golden Retriever was a gun dog but it took 26 years before a club field title was established. The first WC was held at the National Specialty in 1964 with an entry of 8 dogs, and 4 passed. In 1978, 14 years later, the first WCX was held hosted by Long Island GRC. Of the 11 dogs entered 6 passed. And so began the holding of WC/WCX tests.

In 1981 our local club, GRCCNY, was established. It is not known when members became interested in field events but an article in GRCA news written by Janet Dupree in 1988 mentions a field training day with Mary Fowler of Grace Farms lending her expertise on field training.

And so in 1990, with Ted Greenfield as Chairman and Marcia Martin as Secretary, GRCCNY held their first WC/WCX, with an entry of 9 WC dogs and only 1 passing (Ted Greenfield’s Westbrooks Momentary Lapse). Five WCX dogs ran with 3 passing (Mary Hildebrandt’s Comstock Sunfire Tin Emeline and 2 of Les Freer’s dogs). And so began the quest for the WC/WCX title with our members.

Ted Greenfield chaired 1990 thru 1994 and then Dave Tyler took over for 1995 thru 1997. Joe Martin chaired 1998 thru

2000. Marcia Martin held the Secretary position from 1900 thru 2000. And Sallie Lennox has been the Marshall every year but one since 1900. In 2001 Kathy McCloskey and I took over the duties of Chair and Secretary and have remained since.

Entries have increased over the years and so has club interest and participation. With more training days every year the dog work has also seen great improvement.

We had a full entry this year on October 5th at Echoewood in Mexico, NY. Eleven club members ran dogs and with an entry of 12 in WC we gave out ribbons to 10 member/dog teams. The WCX passed 5 member/dog teams. Look at all the smiling faces in the pictures! Judges Joe and Marcia Martin always put on nice tests and are a lot of fun and fun was had by all. A big Thank you to all of you who worked to help make this such a success.

Next year will be our 25th WC/WCX so let's plan something special! Hope to see all of you there.

Q: When I adopted Benny from GRRCNY, it was recommended that we enroll together in an Obedience Class. I haven't yet done so because it seems to me that classes won't help what problems I have with him. I'm not interested in Obedience competition and titles. Am I wrong?

A: In answering your question, I first phoned you to learn what problems you are having with Benny and was pleased – and relieved to hear that the problems are not serious but rather annoying.

- jumping on guests when they first come in.
- sometimes taking things off tables and counters and running off with them.
- some pulling on lead on your walks.

We often recommend obedience training, and sometimes include formal obedience classes as an Adoption Contract item. We do this for two significant reasons:

- 1) the dog-human bond is enhanced by Obedience training because of the quality time spent together in class and in practice. It requires you both learn to focus just on each other. It also helps to clarify who the pack leader really is and the earlier in the relationship this can be established, the better.
- 2) You learn from your instructor and your experience just how dogs learn. They learn
 - because of your **CONSISTENCY**. Same response from you each time; same response from others in your household helps, too.
 - By **REPETITION** – over and over again. You show him many times what you want many, many times and rewarding him by praise, food rewards or a combination of the two.
 - By your **POSITIVE REINFORCEMENT** of the desired behavior and by rewarding only when he demonstrates the behavior you want. Further, by you never giving a command and then ignoring his failure to comply. Better to ignore him in the first place then to tolerate his ignoring of your command.

While SIT, STAY, COME, DOWN, HEEL, and STAND are all expected for the AKC Companion Dog title, not everyone is interested in training with a title as a goal. But most dog owners are interested in training with the goal of a better mannered companion. For your dog to perform these several actions on your command will eliminate many dog behavior problems. Its really simple: a dog can't do something wrong and something right at the same time. A "SIT" with a reliable "Stay" will eliminate your dog's ability to jump on Aunt Susan. And why not ask Aunt Susan to offer Benny a treat before the "Sit/Stay" is released?

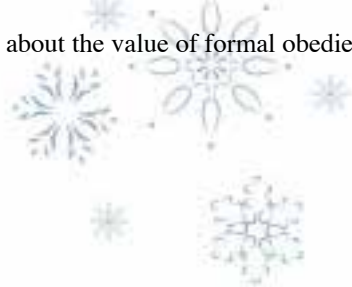
As Dog Trainer Pat Miller recently wrote in YOUR DOG (The Tufts Univ. School of Veterinary Medicine Magazine):

A good positive training class can help in resolving behavior problems by helping you and your dog learn to communicate more clearly with each other. The better you understand how his mind works and the better he understands what it is you expect of him, the stronger the relationship between you. In the end, it's the strength of this relationship that will carry you through the challenges of dog care taking and allow you to experience the joys and rewards of sharing your life with a canine companion.
