In 2009, Nikko was a puppy tied to a tree for most of his first year. His owner had died soon after bringing him home and her grieving husband didn't know what to do with the puppy. Obviously!! Someone told him of GRRRCNY and.....the rest of the story..

Sue Reuss wanted to adopt a young male Golden and, although out of the area in which GRRRCNY typically makes Golden retrievers available for adoption, her application was compelling. Her interest was in providing the opportunity for her dog to participate in as many events as possible. She also requested that the neutering of the dog be delayed consistent with research beginning to appear at that time about the advantages of delayed altering and negative early spay/neuter implications for the canine athlete.

GRRRCNY, mainly working through its Adoption Coordinator, Sallie Lennox, began to discuss Nikko with Sue. GRRRCNY would bend its policy about altering before adoption with the understanding that at the appropriate time this would be done, and it was.
