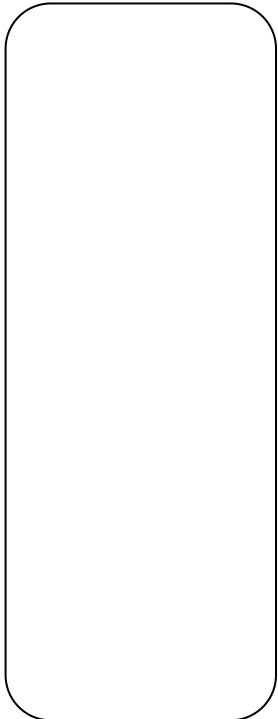

*Held with permission of the Golden Retriever Club of America, under GRCA rules and regulations available on the GRCA website. All dogs entered must be at least six months of age, with individual AKC, ILP or Foreign registration numbers. By special arrangement with the Flat-Coated Retriever Society of America, these tests are open to Flat-Coated Retrievers.*

*Mallard ducks will be used for both the WC and WCX tests. A winger may be used for water marks.*

*No bitches in season on the test grounds! Entire entry fee will be refunded upon veterinary verification of a bitch in season or an injured or deceased dog.*

***Entry Fees, Limits, Closing: WC - \$65 WCX - \$75***  
*Combined total entry limit of 30 dogs for both stakes. If limit is exceeded, preference will be given to Golden Retrievers.*

*Canadian exhibitors must pay with a bank draft in US funds. Personal checks marked "At Par" or US Funds" are not accepted by US banks.*

*Running order will be drawn at 6:00 PM – Mon. Sept. 9, 2024 at the home of the Test Secretary. After that date, entries will be accepted up to the day of the event at an additional \$10 charge. Late entries will be placed at the end of the running order.*
